

Contest Rules and Regulations -

May 20th to September 16th, 2023



- 1. To enter, participant must fill out a registration form of all personal information in full. Identification must be provided showing the participant as a resident in Ontario.
- 2. Participants will be given a starter Zucchini plant after registering and will be required to use the plant to grow the largest Zucchini by September 16th, 2023.
- 3. All participants, on September 16th, 2023, will be required to bring the Zucchini plant that was grown from the starter plant to Paul Sadlon Motors, during the Measuring Day Event.
- 4. One (1) winner who presents their Zucchini on Measuring Day, who has registered by filling out the registration form and is declared the longest Zucchini at the end of the Measuring Day Event, will receive the Grand Prize.
- 5. All participants can only register one entry.
- 6. Measuring Day Event will be September 16, 2023 and all Zucchinis must be made available for measuring that day, before 3pm closing.
- 7. Zucchinis cannot be in parts or sections or broken; they MUST be in one piece.
- 8. All Measured Zucchini participants, after their official measurement, will receive an official Measurement from the Contest Officials.
- 9. One (1) Grand Prize will be awarded: A Trip for Two (2) to the CHIN Italian Winter Picnic 2024. This must be accepted as the award, with no cash substitutions, non transferable

and non-exchangeable, and trips are subject to some restrictions and conditions. No substitutions will be made for the prizes except at the sole discretion of CHIN Radio, which may substitute prize(s) of comparable or greater value. Unless CHIN Radio agrees in writing and at its sole discretion, to extend the date of usage, such trip/flight prize will expire upon the completion date of the CHIN Italian Winter Picnic 2024, and be deemed forfeited by the winner(s), and will have no monetary value or replacement.
